The Wentworth Town Council met on Monday, July 26, 2021 at 6:00 p.m. at the Finance Office. Wayne Backus appeared before council to discuss possible sales of land owned by W.N.P Development Corporation. Backus will update council as sales progress. Backus presented the Town with a check from the Wentworth Fireworks fund in the amount of \$1,351.32 to be used as a donation for Community Barn repairs and/or upgrades.

Council discussed the Wentworth zoning ordinance book, which was last updated in July, 1999. Natwick will contact First District to move forward with rezoning certain areas of town, updating zoning maps in the City Office and updating the zoning ordinances as needed.

Backus, along with Greg & Sandy Johnson, appeared before council to discuss dogs running at large, unauthorized animals within city limits, lawns not being mowed, branches & trash in yards and other rubble in yards & alleys.

Natwick informed Council that the Town of Wentworth was awarded a West Nile Grant in the amount of \$1,342.00.

The South Dakota Department of Agriculture and Natural Resources awarded the Town of Wentworth the Secretary's Award for Drinking Water Excellence for 19 consecutive years.
